- Applications are open as from Monday, 12 April 2021 to Tuesday, 31 August 2021 and should be made on form downloadable from UTM's Website www.utm.ac.mu
 - An Application Fee of Rs1000/- (non refundable) should be payable by telegraphic transfer as per bank details hereunder on submission of the Application Form, duly filled in, and supporting documents (inter alia, scanned copies of educational and birth certificates and scanned copy of bio data page of passport) to be sent electronically, on email address internationaloff@umail.utm.ac.mu.
- For effective processing of the application form, please submit visible and readable scanned copy of the filled application form, along with the supporting documents.
- The choice of programme applied for, should be based, strictly as per the list of programme advertised.
- The closing date for submission of the application form is **at latest by 31 August 2021**.
- A candidate applying to register for PhD (Direct) shall hold an MPhil Degree or a Masters Degree by Research in the field. A candidate holding a First Class Honours Bachelor degree may also apply but will have to successfully clear an interview prior to be considered further.
 - There are two Semesters in an Academic Year.
 - International candidates should also have a minimum of US\$250 per month for expenses such as lodging, food, transport and clothing.
 - Fees are not refundable save exceptional circumstances as provided for in UTM Rules & Regulations (see UTM Website).
 - Only successful applicants will be notified of the outcome of their applications.
 - The UTM reserves the right to alter fees or other charges.
 - The UTM reserves the right not to run any of the above programmes.
 - Tailor-made courses designed at the specific requests of client organisations and considered as in-house training accommodate only students sponsored by client organisations. Exceptionally, non-sponsored students may be accommodated on a case-to-case basis, subject to payment of appropriate fees.
 - Students have to be physically present in Mauritius during a semester to attend classes and attend to assessments. Save in very exceptional circumstances, at least 50% of delivery will be on a face-to-face classroom basis. Need for physical presence in Mauritius is equally applicable to international students.
